(BOVESPA: GFSA3; NYSE, GFA) ("Gafisa" or "Company") hereby discloses to the market the communication received on this date from its shareholders (i) Wishbone Delaware Brazil I, LLC, enrolled with CNPJ/MF under No. 11.704.417/0001-51, and (ii) Wishbone Restricted Partners, LP, enrolled with CNPJ/MF under No. 11.925.127/0001-38, all with headquarters located at 155 North Wacker Drive, 46th floor, in the city of Chicago, Illinois, United States of America, and managed by Wishbone Management, LP ("Investor"), pursuant to Article 12 of CVM Instruction 358/02, as follows:

1. The Investor became the holder of 1,972,272 common shares issued by Gafisa on October 2, 2018, being (i) 1,787,272 shares held by Wishbone Delaware Brazil I, LLC; and (ii) 185,000 shares held by Wishbone Restricted Partners, LP, reaching the total relevant participation of less than 5% of the total capital stock of the Company as of October 1, 2018;
