GAFISA S.A. (BOVESPA: GFSA3) ("Gafisa" or "Company") hereby announces that it extended the maturity of Company's debt totaling four hundred fifty-six million, three hundred sixteen thousand, eight hundred and thirty-two reais and eighty-three centavos (R\$456,316,832.83). The Company's debts will now mature in 2020 and 2021. The debt extension, carried out under the condition precedent of a minimum capital increase of two hundred million reais (R\$200,000,000.00), complies with one of the conditions of the obligation of Wishbone Management, LP, a Company shareholder, in partnership with Conifer Capital Management, LLC and investment funds managed by its affiliated companies. Said condition refers to subscribing to shares and eventual unsubscribed shares within the context of the capital increase to be submitted to approval by the extraordinary shareholders' meeting called to convene on second call at 10:00 a.m., on December 20, 2017.
