“ Planner Corretora de Valores S.A., a financial institution headquartered in the City and State of São Paulo at Av. Brigadeiro Faria Lima, nº 3900, 10º andar, pursuant to CVM Instruction No. 358/2002, amended by CVM Instruction No. 449/07, hereby informs that at trading sessions of BM&FBOVESPA over the last days, ACQUIRED, representing GWI BRAZIL AND LATIN AMERICA MASTER FUND, a non-residing investor enrolled with the corporate taxpayer’s ID (CNPJ) No. 25.350.502/0001-73, common shares issued by Gafisa S.A. enrolled with the corporate taxpayer’s ID (CNPJ/MF) No. 01.545.826/0001-07 (“Company”), and now holds the total amount of one million, four hundred, thirty-five thousand and ninety-six (1,435,096) common shares, corresponding to 5.12% of the Company’s shares.

The Fund points out that this share acquisition has the sole purpose of investment, also informs that: I. It neither holds warrants, share subscription rights nor debentures convertible into shares issued by the Company; and II. It has not executed any agreement or contract regulating the exercise of voting right or the purchase and sale of securities issued by the Company.
